Corporal Jeff Beacham will retire on January 31, 2016 and we will need to discuss a new hire in the future for the August Academy Class. Patrolman Gilkison will return to the Department January 1st to fill the now vacant Detective Division. Captain Woodrow will spend a couple of weeks bringing him up to speed in that office.

Mr. Cocuzza addresses the Sheriff regarding an incident on Dibling Street regarding a young man barricading himself in his home. His parents had come to the police department for help. The young man threatened the police officers. The officers followed procedures and called out the Monmouth County Sheriff's Department CERT team. Mr. Cocuzza and Chief Ervin were on site with Ptl. Friscia, Ptl. Harriott and Special Officer Higgins and Chief Dombrowski, they handled the situation professionally with compassion. They understood that this young man had issues and challenges. They used resources at their disposal and no force was used. He thanks all for their professional response and the County's efforts and resources to back up our Municipal resources.

Sheriff Golden comments on the program and how well we all work together.

Councilman Wicki:

Finance, Personnel and Administration

The number of abandoned properties in the Borough continues to be a serious problem. While we as a Council are doing all that we can do legally, to address the problem, the process moves much slower than what we would like. There are times due to the safety and well being of the residents that we are forced to use our Public Works Employees to clean up these properties. We do have an Ordinance in place that allows us to place a lien on these properties to re-coop the cost incurred by the Borough for performing this work. The Ordinance is very general and the fee schedule is quite ambiguous. For the past three years there are numerous properties that require the services of the Borough workers. The scope of the work performed varies greatly. The amount and type of equipment that is required to be used on these projects. It has become necessary to both clarify the wording of this Ordinance and to specify the fees charged and for what the fees are used for. There is an update on this Agenda for this evening which spells out more specifically the rates per hour and the rate for the equipment used. Our hope is that by placing liens on these properties that we can actually re-coop our costs so that when these properties are sold we do get our money back.

Also, on tonight's agenda we have our Solid Waste, Bulk Refuse and Recyclable Materials Collection and Disposal contract. Our current contract expires at the end of the year. We did receive bids from four companies which were opened on November 12th. It is our intention to award that bid tonight. We are recommending to award to the lowest bidder M&S. Their bid is \$500,000.00 less than the next lowest bidder. This is a 5-year contract period. M&S has been with the Borough for several years. They know the town and have a good repore with the Public Works Department. If there are problems or complaints Mary Mancini gets them resolved very quickly. There are a few concerns by some residents which were factored into the new contract, including starting too early. He wishes all a happy and healthy Thanksgiving with safe travels for all who are travelling to be with loved ones this week.

Councilwoman Roche:

Emergency Svs. (Fire, OEM) American Legion & Seniors

American Legion: November 29 there will be a tailgate party. Veterans Day Service was beautiful as usual.

OEM – Members are looking to further their education with an Emergency Management Program. It is an 80-hour program sponsored by Fairleigh Dickenson. It provides them with three college credits. The course starts on February 4th and is \$400.00 per person and they have not decided how many they will send yet. They are also working on a new evacuation procedure with Monmouth County that is going to be color-coded. (more information to follow) OEM vehicles are being maintained before the winter sets in. OEM is also updating their bylaws. The next meeting will be January 27th at 7 p.m. There is no meeting scheduled for November or December.

EMS, Public Works & Building and Grounds

EMS Report: The squad answered 51 Calls in the month of October -= for over 100 calls and clean up hours.

Thank you to the Men and Women of the EMS who service this town 24 hours a day.

The Recipe Book Fundraiser continues. It is on going. Please contact Jackie Shipley should anyone have any recipes that he or she wishes to share. The EMS is still looking for responsible, committed individuals to help with this important service. Please see Jackie or any member of the EMS for any additional information.

Environmental: The 2015 Bayshore Creek and Wetland Clean Up Program wrapped up this Saturday for the winter 2015 with over 20 volunteers. The removing a truck load of trash from nearby Matawan Creek and nearby Lake Lefferts in the Borough of Matawan. Monmouth County Clean Communities as well as the New Jersey, New York Baykeeper assisted in the clean up. Please note that the Council has done clean up here in Union Beach as well, including across the street at Stone Road Meadows, which is in Hazlet, but also in Flat Creek. The Council Meetings are open to the public. They meet at 7:30 p.m. on the first Thursday of the month at Keyport Borough Hall.

Post Sandy Planning Committee Update: The Committee will resume its monthly meetings sometime in the early part of next year once the committee receives its anticipated grant from the DCA. October was an extremely busy month for the Department of Public Works and aside from the normal maintenance assignments, our DPW has been busy with repairs on the lighthouse here at Borough Hall as well as the gazebo at Ellison Park, which had to be rebuilt. In addition, line stripping has been on-going at Memorial School as well as our First Aid and Fire House Buildings.

The Department of Public Works also has been involved in a number of Environmental projects including Clean Ocean Action's Beach Sweeps in Late October and Clean Shores, which is sponsored by the County. Over the course of the next few weeks our DPW will be decorating for the upcoming holidays and gearing up for any potential snowfall. MEETING OPEN FOR PUBLIC DISCUSSION: November 23, 2015 Meeting

Meeting opens for Public Discussion at 8:39 p.m.

Mr. Patrick Spagnuolo, 400 Campbell Street:

Congratulates the Mayor and Councilmen on their re-election. It was a tough campaign. Discusses the DPW yard being moved and possible senior building at site.

Administrator has written letters to IFF requesting available space from IFF to be possibly be donated to the town so that we could build our DPW over there. We are working on this project.

Mr. Spagnuolo asks about Florence Avenue Creek across the Street from the fence – Soda cans, bottles, maybe signage could be put there regarding a fine or community service for littering.

Mayor: This is a County Road. We can contact the County regarding this matter of signage. This bridge will be replaced soon. It is on their plans and should clean up that whole road.

Mr. Spagnuolo: This has to do with people driving by and littering there.

Mr. Spagnuolo: Regarding the houses to be demolished, not the ones owned by the banks, are the liens being put on those property owners. If they are not doing anything with the house, what are we doing with those houses. He knows that this came up in the literature that was on your campaign that is wasn't going to be a problem.... What happens to those houses, not the ones the

banks own....cause you can probably take liens on them.... But the ones that people have just walked away and abandoned....These are in pretty bad shape.

Mr. Wicki: If they walked away and abandoned them, then the Bank does take them over.

Mr. Spagnuolo: No – if they owned them outright. He is not talking about bank owned houses. Not every one of those 112 houses is owned by banks. There has to be some that are probably owned by regular people.

Mr. Cocuzza: Typically when the homeowners are contacted by the Code Enforcement Office, they find a way to get the work done. Whether they call a maintenance company.

Mr. Spagnuolo: They are just sitting there not doing anything.

Mr. Cocuzza: Most times Bob Parsells our Code Enforcer is here and would tell you that he contacts the residents that own the homes and they manage to get the work done.

Mr. Spagnuolo: You can't make them knock down the house? And the houses should be demolished....

Mr. Cocuzza: Are you talking about cutting grass, etc.

Mr. Spagnuolo: No- not cutting grass, these houses are in bad shape – and should be torn down. What do you do when an owner walks away from the house and it is abandoned and it is not our obligation to tear it down, but it must come down as it has been three years.

Attorney: Yes, we can knock down people's houses if we deem them to be abandoned . There is a statutory definition of abandonment. We passed the abandoned properties list, we are identifying about ten to twelve at a time . The state is agreeing to knock down some of these houses for people with an agreement. If private citizens want them, the state is providing a program to do this. We are identifying the ones (bank ones in particular). There is a process. You put up notice. They have a certain amount of time to demolish. If they don't demolish it in a certain number of days, sir, we demolish it and we put another lien on the property. If that property gets sold for taxes and lien then somebody buys that property, we get paid back. We are trying to avoid this. Most of the time Bob (Parsells) contacts people. People come in, but some of the people really have walked away. In our process to identify people, many older people have moved some place else. They didn't have insurance for exactly that reason. They don't want to go back and start building a house from scratch. The only value is the property and they don't have the money to knock it down. These are the ones we are identifying one at a time. We will be doing this and if we get them to sign off and agree with this than that is even better. We have done this before. We can re-coop the costs through the property being sold through tax sale certificates being sold and then we get our money back and then someone else will eventually acquire the property through a foreclosure. We are also encouraging them if they are going to walk away then to sell them. Sometimes this letting them know that they are on the abandoned property list will get them to do something that they haven't done up until now. Some are waiting for proceeds of insurance sales, but very often when they get to that point where they have their insurance money they are looking for the other money that they will need to rebuild. They are already living someplace else. Attorney outlines some of the criteria for identifying an abandoned property as per statute and the hearing and appeal process.

Mr. Spagnuolo agrees that these are the properties he is speaking about.

Attorney: they cause visual problems, wildlife problems, and security problems.

Mr. Spagnuolo also states mold and asbestos problems may exist.

Attorney: So yes, there are many houses that have not been touched since the storm – these would be at the top of the list - and Yes, we can knock them down after notice and a hearing we can and we can re-coop our costs through a lien on the property.

Mr. Spagnuolo: Discusses the \$17 Million in costs for the Flood Program as cited in the campaign literature – is this totally going to be picked up by the State? Or do we still have to pay some of this?

Mayor Smith: You are reading campaign literature, which is not correct. He is not holding up the project He has spoken to Congressman Pallone – They are working to obtain 100% Federal Funding. This is what we are working on. If we have to come up with \$17 Million which we are prepared to do, we are hoping the County will chip in which they have in the past. We do not have to start paying on our end of the project (if we have to pay anything) until it is complete. We do not have to put any money up front. The government pays for everything and if we have to reimburse anything at the end, we would have 30 years to do this. But we are working on 100% Federal Funding. He won't be happy unless we get that. That is what we are working on.

Mr. Spagnuolo is speaking about the literature about what the State is picking up.

Mayor Smith states that the State is picking up 75% and the State has agreed to maintain it once it is done. This is a big thing.

Mr. Wicki states that the balance left after the State pays its portion is \$17 Million and that is split between County and Local Funding. We are working with other officials to get them to pick up the rest of the money so that it wouldn't cost us anything.

A Congressman had told Mayor Smith that Keansburg and Middletown got 100% because they were shovel ready. Mayor Smith also told the Congressman that our plan was approved in 2007 and we are shovel ready-you just didn't fund us, but we were approved so we were ready to go then – so we should get the \$100% funding – He said he would work on this.

Mr. Spagnuolo: 2015 has past and he hopes we are on board and we are moving towards 2016 to start this project, this flood project

Mayor Smith: I hope so too.

Mr. Spagnuolo: Because at one of the last meetings, you and the Councilman both said that this would start in 2015, which that is already gone....

Mayor Smith: Well the Governor announced in April that it would start the end of 2016.

Attorney: The earliest is 2016 and last news is now that the Federal Government, and the State are negotiating a coastal barrier line whether it is in this very restricted zone. Whether it is going to be built in this very restrictive zone or has to be moved out of the very restrictive zone over by the wetlands by the BRSA. Right now it is a little bit into a very sensitive area that requires the government to sign off on to allow it to be there. If not, it is going to have to be moved over, change the location. This is the only reason it is not signed right now .

Administrator: Robert M. Howard, Jr.: Your figures are correct, but your timing is all wrong. In 2014 when the Federal Government first funded the 6.1 million to Army Corp and all the projects were listed and Union Beach was part of that list, in 2014 they said it would begin construction in 2015, but when the Governor and Army Corp Generals and everyone appeared here in April of 2015, at that time the announcement was made that construction was expected to begin in the 2nd half of 2016. Officially, that is still what everyone is saying. What John Lane and the Mayor have eluded – yes, there is an environmental issue that has come up.

Attorney: Is it in Zone 1.

Administrator: No it is not in Zone 1 or Zone 2 the beachfront and Brook Avenue areas. It is on the west side of town. So, everything you are saying is correct, your recollection of when that information came out is incorrect. In April of 2015 the Federal Government and Governor Christie indicated that it would begin the 2nd half of 2016, which it officially still is.

Mayor Smith: We also sent letters to Congressman Pallone, Senator Booker and Senator Menendez with this latest problem and they have all responded back that they are working on it.

Mr. Spagnuolo: He could not see what was holding us up. The entire shore has started and we have not even put a shovel in the ground yet.

Mayor Smith: The Army Corp has met with Fish and Wildlife in DC last month and we are waiting to hear. Our people are a lot more important than some fish.

Mr. Spagnuolo: He doesn't want what happened in the 1990's when they cancelled the flood plan that we already had. He doesn't want to point any fingers but people thought that it wasn't necessary to go through with that flood plan at that time so he is hoping that this one will go through. We were way ahead of everybody on the Jersey Shore back in the early 1990's with that flood plan. No other Jersey Shore town had a flood plan like we had and that was killed...

Mayor: No we never got funded. – it is the same project. – The more you wait the longer it will cost.

Administrator: As the Mayor eluded to, it is a \$2.02 Million Dollar project. The Federal Government picks up \$131 Million and the State picks up \$53 Million so \$184 Million of the \$202 Million is coming from the Federal and State Government. If they are not willing to give the money to put the shovels in the ground then it will not get done until they are prepared to do it. The Borough cannot pick up \$202 Million Dollars worth of the expense:

Mayor: The Borough couldn't

Mr. Spagnuolo: You have answered my questions. He just wanted to make sure that we are proceeding the best we can. He just wants to get this flood plan gone through without any hiccups.

Mayor Smith: We are working on it.

Mr. Spagnuolo: Wishes all a Happy Thanksgiving.

With no one else appearing to be heard, Mayor Smith closes the Meeting for Public Discussion at 8:50 p.m.

RESOLUTION NO. 2015-187: Requesting a Dedicated Trust by Rider be approved for the Disposal of Forfeited Assets

Resolution Requesting Approval of the Director of Local Government Services for to Establish a Dedicated Trust by Rider for Disposal of Forfeited Property (NJS 2C:64-6)

WHEREAS, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonable accurate estimates in advance, and

WHEREAS, N.J.S. 40:55d-53.1 allows municipalities to receive amounts for disposal of forfeited property, and

WHEREAS, N.J.S.A.40a:4-39 provides that the Director of the Division of Local Government Services may approve expenditures of monies by dedication by rider,
