16-10.1 Lighting Restrictions

<u>A.</u>

Sports lighting has been constructed at Helen Harding Memorial Park in order for the athletic fields therein to be utilized after dark.

<u>B.</u>

The aforementioned sports lighting shall go on at dusk and be turned off no later than 8:30 p.m. Sundays through Thursdays and go on at dusk and be turned off no later than 9:30 p.m. Fridays and Saturdays.

<u>C</u>.

The above restriction is a condition of partial funding of the 2019 lighting project by the Monmouth County Board of Chosen Freeholders through the County of Monmouth Municipal Open Space Grant Program and memorialized in Grant Agreement dated March 29, 2019.

Total Emergencies for the month were approximately 45. The EMS continues to provide mutual aid to Hazlet, Atlantic Highlands, Highlands and Holmdel. The EMS continues to make updates to its rigs which include child restraints for at least two of the rigs so far. They are also preparing to add albuterol to the rigs for treating respiratory distress. They are awaiting for the State to give approval. It should also be noted that the EMS in now participating in holding a leadership position in the Bayshore EMS Line Officers Association so congratulations to all those people providing that service. Thank you and congratulations to our EMS for a great 2019. New members are always welcome.

<u>Planning Committee</u> is currently awaiting updates from potential developers of the Cervino site and the vacant parcel at the corner Florence and Front Streets. We expect to hear from both in the spring.

Public Works: The Department has been very busy preparing for the winter and the Holiday Season. Christmas trees and holiday decorations were displayed at Ellison Park for the first time. We had the Beachfront and the Recreation Commission Tree Lightings on December 8th at Scholer Park. He thanks the staff and the department of Public Works for their contribution to these beautiful displays. It is a very horrible, emotional thing. He has five children and by all accounts, he was as good man.

This addendum to AIA Document B101-2007 Standard Form of Agreement Between Owner and Architect ("Addendum") is entered into this 19th day of December, 2019 by and between the Borough of Union Beach ("Owner"), with offices located at 650 Poole Avenue, Union Beach, New Jersey 07735, and The Goldstein Partnership (Architect"), with offices located at 515 Valley Street, Suite 110, Maplewood, New Jersey 07040.

WHEREAS, the Owner and Architect entered into an AIA Document B101-2007 Standard Form of Agreement Between Owner and Architect ("Agreement") for the Architect to provide professional services in connection with the Renovations & Addition to the Union Beach Municipal Building project ("Project"); and

WHEREAS, the Agreement contemplates that additional and/or extended services might be required of the Architect;

and

WHEREAS, as a result of the Project Contractors' delays and failures; the Architect has provided extended services beyond those required by the Agreement; and

WHEREAS, the Owner agrees that the extended services are required due to the fault of the Contractors; and

WHEREAS, the Architect submitted an invoice in the amount of \$13,535.00 for its extended services between April 1, 2019 and November 30, 2019; and

WHEREAS, the Owner reviewed the invoice and determined that the time spent is reasonable and the amounts invoiced are consistent with the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, conditions and agreements contained herein and in the Agreement, the Owner and Architect desire to amend the Agreement as follows:

- 1. The above recitals are incorporated herein by reference.
- 2. The Architect's fees for the Project shall be increased in the amount of \$13,535.00 which amount shall be invoiced in accordance with the terms and conditions of the Agreement.
- 3. The Contract Sum for the construction of the project as set forth in the Owner/Contractor Agreement shall be reduced in the amount of \$13,535.00. The Architect shall prepare the necessary documents to reduce the Contract Sum and/or back charge the Contractor and/or include in claim against the Surety the fees for the Architect's extended services.
- 4. All other terms and conditions of the Agreement remain in full force and effect and shall apply to the services set forth in the Proposal.
