Ordinance 2020-295:

<u>Mayor Cocuzza</u> directs the Clerk to read the Ordinance by Title only, advising that said Ordinance was posted on the Bulletin Board at the Municipal Building and on the Borough's Website at least one week in advance of this Public Meeting, and that copies of said Ordinance were made available to the General Public upon request.

ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$235,000, OR SUCH OTHER AMOUNT CERTIFIED BY THE DIRECTOR OF THE DIVISION OF LOCAL GOVERNMENT SERVICES, FOR THE PURPOSES SET FORTH IN N.J.S.A. 40A:4-53(L) AND/OR N.J.S.A. 40A:4-53(M), IN AND BY THE BOROUGH OF UNION BEACH, IN THE COUNTY OF MONMOUTH, NEW JERSEY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE BOROUGH OF UNION BEACH, IN THE COUNTY OF MONMOUTH, NEW JERSEY AS FOLLOWS:

Section 1. The Borough of Union Beach, in the County of Monmouth, New Jersey (the "Borough") hereby appropriates an aggregate amount of \$235,000 to provide for (i) the immediate preparation, response, recovery, and restoration of public services during such time as a public health emergency, pursuant to the "Emergency Health Powers Act," P.L.2005, c.222 (C.26:13-1 et seq.), declared in response to COVID-19 remains in effect, in the amount of \$0, pursuant to N.J.S.A. 40A:4-53(1) and (ii) a deficit in operations experienced by the Borough during fiscal year 2020, in which a public health emergency pursuant to the "Emergency Health Powers Act," P.L.2005, c.222 (C.26:13-1 et seq.), or a state of emergency, pursuant to P.L.1942, c.251 (C.App.A:9-33 et seq.), or both, has been declared by the Governor in response to COVID 19, in the amount of \$235,000, pursuant to N.J.S.A. 40A:4-53(m). The appropriation authorized hereby shall be in the individual and aggregate amounts set forth herein or such other amounts as certified by the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey (the "Director").

Section 2. The Borough shall apply for any financial assistance that may be available to the Borough from the federal government, the State of New Jersey, and other sources to offset any operating deficit directly attributable to COVID-19, and any such financial assistance obtained by the Borough shall be utilized to offset any operating deficit.

Section 3. A copy of this ordinance as finally adopted shall be filed with the Director.

Section 4. This ordinance shall take effect upon the latter of (i) the date determined by applicable law or (ii) the earlier of (a) the date the Director approves in writing the application submitted by the Chief Financial Officer of the Borough for approval of the special emergency authorized hereby (the "Application") and (b) the date that is 45 days (or the first business day following such 45th day, if applicable) following the date the Chief Financial Officer submits the Application to the Director.

Robert M. Howard, Borough Administrator - Nothing to add. Dennis Dayback / Ed Broberg, Borough Engineer - Engineer discusses his project status report

- Army Corp. Now working with the state to get release of the appraisals so that we can start negotiations with property owners. Hoping that happens quickly and we can get this project underway. Plans are done they have pushed the bid date now to September. We just need to secure easements. John Lane was working on that and Bob and Dennis are going to discuss this matter.
- Turf Maint plan bids expected Dec 16. if favorable hopes to award on December 17th. He added a few things to the specs like ballfields with a lot of weeds on the infield areas.

Spray has been done but they don't come back to pull the weeds. The spec now says spray and return to pull the weeds in the infield areas as well as the warning track. He has also added issues from the goal mouths being worn out on the soccer fields every season. We do not have enough time in between seasons to get the grass to grow. He has added new sod to be placed in the goal mouths every fall. This will allow for that grass to take for the next spring season. This year's contract he has one time only the main field that the goal mouths be done in the spring of this year – every year after that in the fall. He also has that if we have other areas on the field that get worn out that sod can be replaced as well. The Borough Hall plantings and landscaped areas will be addressed by weeding in the spring and late summer and in the spring they will supplement the mulch that is around the building now. Just at Borough Hall so it is always nice and neat. These three changes are in the contract and we will be receiving bids on Dec. 16th and he hopes if all is well to award at the next meeting.

- 3. Ocean/Lorillard projects are complete we are in DOT close out.
- 4. 9th Street we are awaiting for the release of the HUD funds, CDBG money. We have to get that done early spring of next year because we are up for another project that we will discuss early January.
- 5. Monmouth County Open Space- we have not heard anything on our application.
- 2021 DOT Application we received good news for Prospect Avenue we have a \$375,000 grant for the reconstruction of Prospect Avenue.- this is the entire length. It will not cover all the expenses but it is a decent grant. It is one of the largest to be given out this year. We have been very successful with our DOT grants.
- 7. Solid Waste Recycling as everyone knows we received bids and we will be discussing the bid negotiation in closed session tonight.
- 8. Our redevelopment plans –our planning studies/ redevelopment of Cervino's that site is going to make a submission to the Planning Board. We are moving on that. The buildings are down. This even makes a difference. It is almost cleaned up. We are supposed to be meeting with the potential developer of the Florence Avenue/Front Street site – Ciglia Transmission site – they will be meeting in Early January with the Planning Committee.
- 9. There has not been any movement on the PW's

Councilman Lewandowski asks if Dennis has gotten a chance to look at the leaking water on Florence Avenue by GPU. He did look at it and it is a pipe that is coming out of the wetland area. He does not know where it is coming from. It is not coming from the JCP&L site. It looks like there is a drain in the wetlands area. This was an issue a few years ago and we referred it to JCP&L. Dennis went back as far as he could. Mr. Lewandowski states that this is an issue for us if it freezes every year. Dennis Dayback states also an issue in the past was where the water was coming out into Broadway.
