RESOLUTION REQUESTING PERMISSION FOR THE DEDICATION BY RIDER FOR DONATIONS FOR THE REPAIR AND REHABILITATION OF SCHOLER PARK HOCKEY RINK IN MITIGATION OF DAMAGES CAUSED BY SUPERSTORM SANDY IN THE BOROUGH OF UNION BEACH

REQUIRED BY NJSA 40A:4-39

WHEREAS, N.J.S. A. 40A:4-39 requires permission of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonably accurate estimates in advance; and

WHEREAS, the Borough of Union Beach has or will receive donations as per N.J.S.A. 40A:5-29 for the benefit of the residents of Union Beach to relieve the damages and dislocations caused by Superstorm Sandy; and

WHEREAS, the Mayor and Borough Council have determined to use these donation to repair the recreational facilities at Scholer Park the cost to repair said damages are not covered by any insurance or other grants or loans to make said repairs; and

WHEREAS, the allowance of a Dedication by Rider for the collection and expenditure of said funds would provide for a more orderly method of accounting for said funds;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Union Beach, in the County of Monmouth, that in accordance with **N.J.S.A. 40A:4-39** the dedication of funds collected as Donations dedicated for repair the recreational facilities at Scholer Park (Hockey Rink) taking place in the Borough are hereby anticipated as revenue and are hereby appropriated for the purpose to which said revenue is dedicated by statute or other legal requirement.
