ORDINANCE NO.: 2023 -323 :

An Ordinance Amending Chapter 11 (Sewer and Water) of the General Ordinances of the Borough of Union Beach, County of Monmouth, State of New Jersey to Amend Certain Definitions Within Subsection 11-2.3 and add to 11-2.8.

BE IT ORDAINED by the Borough Council of the Borough of Union Beach, County of Monmouth, and State of New Jersey that Chapter II (Sewer and Water) of the General Ordinances of the Borough of Union Beach is hereby amended or supplemented as follows:

Subsection 11-2.3 Definitions (c.) and (l.) are amended to read as follows:

- c. BUILDING SEWER – Shall mean the extension from the building drain to the cleanout within the public right-of-way, or lacking such facility within the public right-of-way, a point two feet behind or inside the edge of curb or edge of pavement.
- l. PUBLIC SEWER – Shall mean a sewer in which all owners of abutting properties have equal rights and is controlled by the public authority and shall include that portion of the lateral sewer extending from the main to the cleanout within the public right-of-way or, lacking such facility within the public right-of-way, a point two feet behind or inside the curb or edge of pavement.

Subsection 11-2.8: Building Sewers and Connections is amended to include the following

(m.) Notwithstanding any language contained within this chapter, all connections are to be made to an existing sewer main, a BRSA trunk or interceptor sewer or an existing feeder line into one of the above. The costs and expenses associated with the installation and connection shall be borne by the owner.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Pursuant to the provisions of N.J.S.A. 40:69A-181 (b), this ordinance shall take effect twenty (20) days after its final passage by the Borough Council and approval by the Mayor where such approval is required by law.

This ordinance shall take effect after final passage and publication as provided by law.
