

**BOROUGH OF UNION BEACH**

**ORDINANCE NO. 2016-241**

**AN ORDINANCE AMENDING AN ORDINANCE ENTITLED “THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF UNION BEACH, 1980,” CHAPTER VII, TRAFFIC**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF UNION BEACH that Chapter VII, Traffic is hereby amended as follows:

7-3.2 Parking Prohibited During State of Emergency.

a. Upon the declaration of an emergency, there shall be no parking upon streets or sections of streets where temporary EMERGENCY-NO PARKING signs are displayed. The chief of police or, in his absence, the ranking police officer is authorized to declare an emergency and to direct the posting of EMERGENCY NO PARKING SIGNS when weather conditions, accidents, fires or public celebration dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic. Notification that EMERGENCY NO PARKING signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the signs.

7-3.3 Parking Prohibited at All Times on Certain Streets.

No person shall park a vehicle at any time upon any of the streets or parts thereof described in Schedule I attached to and made a part of this chapter.

7-3.9 Parking in Front of Private Driveways, by Permit.

f. The permits acquired pursuant to this subsection shall expire on June 30th of each calendar year and an administrative fee of ten (\$10.00) dollars shall be paid annually for the first permit issued to a private driveway owner and two (\$2.00) dollars for each additional permit acquired pursuant to this subsection.

7-3.11 Student Drop-Off Zone.

The following location is hereby designated a Student Drop-Off Zone to be used for dropping off and picking up students and other persons entering or leaving the school:

Name of Street	Sides	Location
Wilson <b>Street</b>	East (school side)	From Morningside Avenue to the southerly right-of-way line of the <b>Henry Hudson Trail</b> .

Pursuant to N.J.S.A. 39:4-139 no operator of a vehicle shall stand or park the vehicle for a period of time longer than is necessary to drop off or pick up students or other passengers which time shall not consume more than three minutes.

#### 7-3.12 Overnight Parking

It shall be unlawful to park any tractor-trailer cab, all trucks having a net weight of more than four tons, boat or water craft trailers or recreational vehicles, on any street within the Borough of Union Beach, between the hours of 12 midnight and 6:00 a.m.

When a member of one of the building or service trades, such as a carpenter, electrician, painter, plumber or T.V. repairman, etc. is engaged in loading or unloading or parking of a service truck, during performance by such person of his job on a particular property, he shall be exempt from the terms of this subsection.

#### 7-6.2 Stop Intersection.

Pursuant to the provisions of R.S. 39:4-140, the intersections described in Schedule VIII attached to and made a part of this chapter are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

## SCHEDULE I

### NO PARKING

In accordance with the provisions of subsection 7-3.3, no person shall park a vehicle at any time upon any of the following described streets or parts of streets.

Name of Street	Sides	Location
Cambridge Avenue	North	From Union Avenue east to terminus at East Creek.
Front Street	South	Between Beach Street and Florence Avenue
Spruce Street	West	From Center Street to the northerly right-of-way line of the Henry Hudson Trail.
Spruce Street	East	From Morningside Avenue to a point 35' north of the Henry Hudson Trail.
Stone Road	East (NE)	Entire length.
Wilson Street (Avenue)	East (school side)	From Morningside Avenue to the southerly right-of-way line of the Henry Hudson Trail.

SCHEDULE II

PARKING PROHIBITED CERTAIN HOURS

In accordance with the provisions of subsection 7-3.4 no person shall park a vehicle between the hours specified upon any of the following described streets or parts of streets.

Name of Street	Sides	Hours	Location
Wilson Avenue	East	Between 7:30 a.m. and 3:30 p.m. when school is in session.	From Scholer Drive to Morningside Avenue.

Schedule II, Cont.

Parking Prohibited on Certain Streets to Enable Street Sweeping.

a. There will be "No Parking" on the following streets, on the following days from March 1st to November 1st between the hours of 9:00 a.m. until 3:30 p.m. on the days and streets designated below and made a part of this chapter.

Parking Prohibited on Certain Streets to Enable Street Sweeping.

c. All parked vehicles in violation of this subsection are subject to be towed at the expense of the owner.

d. Basketball apparatuses, mailboxes, planters, trash receptacles shall be placed off road and away from the curblineline so as not to interfere with the sweeping on the day designated below.

fe Trees, tree branches and/or shrubs protruding over and into the curblineline shall be maintained by the property owner in order to allow safe clearance during sweeping operation.

## SCHEDULE VII

### THROUGH STREETS

#### Beach View Avenue

Entire length except where it intersects with Central Avenue.

#### Broadway

From Florence Avenue to Municipal Boundary at Chingarora Creek.

#### Central Avenue

a. Between Union Avenue and Seaview Avenue, except where it intersects with Shore Road.

#### Donnelly Street

Entire length.

#### Edmunds Avenue

Between Chingarora Street and Florence Avenue.

#### Florence Avenue

From Front Street to Municipal Boundary at Stone Road.

#### Jersey Avenue

a. Between Union Avenue and Rose Lane.

#### Johnson Avenue

a. Between Florence Avenue and Newark Avenue.

#### Morningside Avenue

Between Jersey Avenue (Washington Avenue) and Union Avenue.

#### Ocean Avenue

c. Between Columbia Avenue and Brook Avenue, except where it intersects with Park Avenue.

#### Orange Avenue

a. Between Harrison Avenue and Poole Avenue.

#### Park Avenue

Between Poole Avenue and Union Avenue, except where it intersects with Pine Street and Spruce Street.

#### Poole Avenue

Entire length, except where it intersects with the Northerly section of Stone Road

Scholer Drive

Entire length, except where it intersects with Dibling Street.

Shore Road

b. Between Columbia Avenue and Brook Avenue

Spruce Street

Entire length except where it intersects with Park Avenue.

Stone Road

a. Between N.J. Route 36 and Poole Avenue.

b. Between Newark Avenue and Municipal Boundary at Chingarora Creek, except where it intersects at Florence Avenue

Wesley Avenue (Hill Avenue)

From N.J. Route 36 to Willow Street.

SCHEDULE VIII

STOP INTERSECTIONS

Jersey Avenue (Washington Avenue) and Morningside Avenue

A STOP sign shall be installed on Jersey Avenue (Washington Avenue).

Park Avenue and Pine Street

The intersection of Park Avenue and Pine Street shall be designated a FOUR-WAY-STOP, with appropriate stop signs on each corner.

SCHEDULE XII

BUS STOPS

b. Along Broadway, westbound on the northerly side thereof

2. Johnson Avenue: (far side)

Beginning at the westerly curblineline of Johnson Avenue, if extended northerly, and extending 100 feet westerly therefrom.

Schedule XII, Cont.

c. Along Florence Avenue northbound, on the easterly side thereof at:

5. Center Street: (near side)

Beginning at the southerly curblines of Center Street and extending 100 feet southerly therefrom.

Schedule XII, Cont.

- g. Along Union Avenue northbound on the easterly side thereof at:
  - 4. Park Avenue: (far side)

Beginning at the northerly curblines of Park Avenue, and extending 100 feet northerly therefrom.

- h. Along Union Avenue southbound of the westerly side thereof at:
  - 2. Park Avenue (near side)

Beginning at the northerly curblines of Park Avenue and extending 100 feet northerly therefrom.

- 3. Columbia Avenue: (far side)

Beginning at the southerly curblines of Columbia Avenue and extending 100 feet southerly therefrom.

- 4. Washington Avenue: (near side)

Beginning at the northerly curblines of Washington Avenue and extending 105 feet northerly therefrom.

SCHEDULE XIII

NO LEFT TURN

There shall be no left turn permitted from Morningside Avenue, eastbound, into the Memorial School Drop-off Area.

SCHEDULE XVI

NO RIGHT TURN ON RED SIGNAL

In accordance with subsection 7-10.4, no person shall make a right turn when facing a steady red signal (STOP) indication at any of the following locations.

On Seagate Avenue, southbound, at New Jersey State Highway Route 36.

SCHEDULE XVIII

PARKING FOR HANDICAPPED PERSONS

b. Private Residences.

Street	Number of Spaces	Location
Scholer Drive (30)	1	In front of 30 Scholer Drive.

BE IT FURTHER ORDAINED, that if any provision, paragraph, section or subsection of this chapter be found unconstitutional or invalid by a court of competent jurisdiction, the remaining provisions of this chapter shall remain in full force and effect and shall have continuing validity; and

BE IT FURTHER ORDAINED, that all other sections of the ordinance remain in full force and effect; and

BE IT FURTHER ORDAINED, that this ordinance shall take effect immediately upon final adoption in accordance with law.
