# SBA to Close Some Recovery Centers in New Jersey; Last Chance to Get One-On-One Assistance

ATLANTA – The U. S. Small Business Administration announced today that due to a steady decrease of activity, the Recovery Centers located in Bergen, Essex, Hudson and Union counties will cease operations on Feb. 11. The Centers located in Atlantic, Monmouth and Ocean counties will remain open until further notice. However, in observance of Presidents' Day, the Centers located in Atlantic and Ocean counties will be closed on Friday, Feb. 12 and Monday, Feb. 15; the Monmouth County Center will be closed on Feb. 15 for the holiday.

SBA's Customer Service Representatives are available at the Centers to answer questions from businesses and residents affected by Superstorm Sandy about the disaster loan program and help survivors complete their applications.
