## **ORDIANCE NO. 2015-1**

ORDINANCE AMENDING ORDINANCE NO. 93-2 AN ORDINANCE FIXING THE COMPENSATION OF OFFICERS AND MEMBERS OF THE BOARD OF HEALTH OF THE BOROUGH OF UNION BEACH FOR THE FISCAL YEAR 2014

BE IT ORDAINED, BY THE BOARD OF HEALTH, OF THE BOROUGH OF UNION BEACH, COUNTY OF MONMOUTH STATE OF NEW JERSEY AS FOLLOWS:

SECTION 1. THE FOLLOWING SHALL CONSTITUTE THE SALARIES OR FEES OF THE INDICATED OFFICIALS FOR THE FISCAL YEAR 2014. AND PAYMENT THEREOF SHALL BE ON THE TIME BASIS AS HEREINAFTER PROVIDED.

- (1) PRESIDENT OF THE BOARD OF HEALTH, THREE HUNDRED TWENTY-FIVE DOLLARS (\$325.00) PER ANUM, PAYABLE SEMI-ANNUALLY.
- (2) VICE-PRESIDENT OF THE BOARD OF HEALTH, TWO HUNDRED FIFTY DOLLARS (\$250.00) PER ANNUM, PAYABLE SEMI- ANNUALLY.
- (3) MEMBERS OF THE BOARD OF HEALTH, TEN DOLLARS (\$10.00) FOR EACH MEETING ATTENDED, PAYABLE SEMI-ANNUALLY.
- (4) ALTERNATES WILL RECEIVE TEN DOLLARS (\$10.00) FOR EACH MEETING SEATED, PAYABLE SEMI-ANNUALLY.

SECTION 11. ALL SALARIES, WAGES, FEES OR COMPENSATION ENUMERTED HEREIN SHALL BECOME EFFECTIVE, RETROACTIVE TO JANUARY 1, 2014, PROVIDED THE EMPLOYEE IS STILL IN THE EMPLOY OF THE BOARD OF HEALTH AT THE TIME THIS SALARY ORDINANCE IS ADOPTED.

SECTION III. ALL ORDINANCES OR PARTS OF ORDINANCES, OR RESOLUTIONS OR PARTS OF RESOLUTIONS INCONSISTENT HEREWITH ARE HEREBY REPEALED.

SECTION IV. THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON ITS ADOPTION AND PUBLICATION ACCORDING TO LAW.

SECTION V. WHEN IT IS NECESSARY TO REPLACE A BOARD MEMBER, ALTERNATE NO. 1 WILL BE APPOINTED AS A PERMANENT MEMBER & ALTERNATE 2 WILL MOVE UP TO ALTERNATE 1. THE MAYOR & COUNCIL WILL BE THEN APPOINT ALTERNATE NO. 2.
