BOROUGH OF UNION BEACH ORDINANCE NO. 2021-298 AN ORDINANCE AMENDING CHAPTER II, ADMINISTRATION BE IT ORDAINED by the Borough Council of the Borough of Union Beach, County of Monmouth and State of New Jersey that Chapter II, Administration of the General Ordinances of the Borough of Union Beach is hereby amended or supplemented as follows: Purpose: The Purpose of this Ordinance is to Amend and/or Supplement the Revised General Ordinances of the Borough of Union Beach, Chapter II, Administration Re: Amend Various Sections of Chapter 2-7, Fire Department 2-7 Fire Department (add gender neutral language) 2-7.1 Composition of Fire Department (amend gender references) 2-7.3 Officers of the Fire Department (text revisions) 2-7.5 Absence of the Chief; Duties of Deputy Chiefs (amend section title and text revisions) 2-7.6 Fire Police (text revision) 2-7.7 Equipment (text revision) 2-7.8 General Regulations (text revision) BE IT FURTHER ORDAINED, that if any provision, paragraph, section or subsection of this chapter be found unconstitutional or invalid by a court of competent jurisdiction, the remaining provisions of this chapter shall remain in full force and effect and shall have continuing validity; and BE IT FURTHER ORDAINED, that all other sections of the ordinance remain in full force and effect; and BE IT FURTHER ORDAINED, that this ordinance shall take effect immediately upon final adoption in accordance with law.
